REGULATIONS

MADE BY THE MINISTER OF NATIONAL SECURITY UNDER SECTION 244
OF THE DEFENCE ACT

THE DEFENCE (RATES OF PAY AND ALLOWANCES)
(AMENDMENT) REGULATIONS, 2023

1. These Regulations may be cited as the Defence (Rates of Pay and Allowances) (Amendment) Regulations, 2023.

2. In these Regulations, “the Regulations” means the Defence (Rates of Pay and Allowances) Regulations, 1989.

3. The Regulations are amended in regulation 20, by inserting after subregulation (3) the following subregulation:

“(4)The entitlement mentioned in subregulation (1) ceases where the member is entitled to and receives a seagoing allowance or turbulence allowance under regulation 26K.”

4. The Regulations are amended in regulation 23, by deleting the words “and the Coast Guard” and substituting the words “, the Coast Guard, the Air Guard and the Trinidad and Tobago Defence Force Reserves”.

26E. An Other Rank is entitled to an instructor allowance, at a rate set out in Part II of the Schedule, where the Chief of Defence Staff requires him to conduct recruitment or orientation training.

26F. A member of the Force who is assigned to the National Coastal Surveillance Radar Centre, and is required to operate and conduct primary level maintenance on assets of the National Coastal Surveillance Radar Centre, is entitled to a radar operator allowance at a rate set out in Part II of the Schedule.

Dog handler allowance	<p>26G. A member of the Force is entitled to a dog handler allowance, at a rate set out in Part II of the Schedule, where he is—</p> <p style="margin-left: 40px;">(a) required to handle a canine and completed a course of canine training; or</p> <p style="margin-left: 40px;">(b) trained and certified as a Canine Instructor, and required by the Chief of Defence Staff to use his knowledge and training to handle a canine as part of his official duty on an ongoing basis.</p>
Information technology technician allowance	<p>26H. An Other Rank is entitled to an information technology technician allowance, at a rate set out in Part II of the Schedule, where he is certified with any of the following accredited qualifications:</p> <ul style="list-style-type: none"> (i) Bachelor of Science in Computing and Information Systems; (ii) Bachelor of Science in Applied Computer Science; (iii) Diploma in Computer, Network and Telecommunication Technology; (iv) Diploma in Computing and Information Systems; (v) Level 4 Diploma in Business Information Technology; (vi) CompTIA A+; (vii) Cisco Certified Network Associate (CCNA); (viii) Cisco Certified Network Professional (CCNP); (ix) CompTIA Security +; or (x) CompTIA Network +, <p>and required by the Chief of Defence Staff to use his knowledge and training in the performance of his duties.</p>
Incentive allowance for Pilots, Rear Crew and Aviation Engineers	<p>26I. A member of the Force is entitled to an incentive allowance for Pilots, Rear Crew and Aviation Engineers, at a rate set out in Part II of the Schedule, where the Chief of Defence Staff requires him to use his knowledge and training as a pilot, co-pilot, rear crew or an aviation engineer in the performance of his/her duties.</p>
Compensation to the Strategic Think Tank	<p>26J. (1) Subject to subregulation (2), a Part-Time Reserve of the Trinidad and Tobago Defence Force Reserves appointed to the Defence Force Strategic Think Tank is entitled to compensation at a rate set out in Part II of the Schedule.</p>

(2) A Part-Time Reserve of the Trinidad and Tobago Defence Force Reserves appointed to the Defence Force Strategic Think Tank shall comprise officers with qualifications and expertise in the fields of finance, law, medicine, human resource management, logistics or other fields required by the Chief of Defence Staff.

Seagoing allowance and turbulence allowance

26K. A member of the Force is entitled to a seagoing allowance and turbulence allowance, at a rate set out in Part II of the Schedule, where the Chief of Defence Staff requires him to be deployed on seagoing, air surveillance, reconnaissance and Inter-Agency Task Force (IATF) joint patrols.

Extra baggage allowance

26L. A member of the Force who is selected to attend an overseas course or training is entitled to an extra baggage allowance, at a rate set out in Part II of the Schedule, where the Chief of Defence Staff requires him to travel overseas.”.
