1. The Committee's First Interim Report was presented in the Senate on Tuesday February 8, 2022 and in the House of Representatives on Friday February 11, 2022. Your Committee requested and was granted a five (5) month extension to June 30, 2022 in order to complete its work.

WORK TO DATE

4. During preliminary discussions, your Committee considered the work completed by the previous Committee during the First Session of the Twelfth (12th) Parliament. Based on this review, your Committee agreed to extend the deadline for the submission of written comments on the Bill to March 31, 2022.

7. Your Committee commenced and completed a review of the general comments on the Bill using the Matrix of Consolidated Stakeholder Comments ('the Matrix') with the assistance of technocrats from the Office of the Chief Parliamentary Counsel (CPC) and the Maritime Services Division (MSD), Ministry of Works and Transport.
8. Your Committee also embarked on a clause by cause examination of the Bill together with the Matrix with the assistance of technocrats from the CPC and the MSD. However, your Committee was unable to reach very far given the complexity of the Bill.

REPORT

9. In accordance with Standing Orders 114(1) and 104(1) of the House of Representatives and the Senate respectively, your Committee wishes to report that due to the imminent prorogation of the Second Session of the Twelfth Parliament, it is unable to complete its work. However, your Committee has made good progress in advancing the Committee's work schedule.

RECOMMENDATION

10. Your Committee therefore recommends the resumption of proceedings on the **Shipping Bill, 2020** in the Third Session, Twelfth Parliament.
11. Your Committee also asks that the House takes note of the work achieved and the progress made by the Committee thus far and that a Committee be appointed in the Third Session to continue work on the Bill and adopt as part of its records, all work completed to date.
