- **141Q**. (1) The Tobago Legislature shall continue for four years from the date of its first meeting after any primary election, and shall then stand dissolved.
- (2) A primary election for the House of Assembly shall be held on the second Monday after the date of the fourth anniversary of the last primary election.
- (3) Where the date specified under subsection (2) is a public holiday or the date of a general election, the primary election of the House of Assembly shall be held on the Monday of the following week

## **OPTION 1 (TRADITIONAL ROUTE):**

141Q (1) Tobago Legislature shall continue for four years from the date of its first meeting after any primary election and shall then stand dissolved; unless dissolved earlier by a resolution supported by a majority of two thirds of the Assembly Members, or by the President acting in accordance with section 141L (1).

(2) The President shall, after consultation with the Chief Secretary, fix the date of a primary election of the House of Assembly, which date shall not be earlier than the expiration of one month after the date of any dissolution nor later than the expiration of two months after that date.

## **OPTION 2 (FIXED TERM):**

141Q (1) The Tobago Legislature shall be dissolved:

- (a) four years from the date of its first meeting after any primary election, or
- (b) by a resolution supported by a majority of two thirds of the Assembly Members, or
- (c) by the President, acting in accordance with section 141L (1)
- (2) A primary election for the House of Assembly shall be held:
- (a) on the second Monday after the date of the fourth anniversary of the last primary election, or
- (b) on the fourth Monday after the date of any dissolution in accordance with subsections 1 (b) or 1 (c)
- (3) Where the date specified under subsection (2) is a public holiday or the date of a general election, the primary election of the House of Assembly shall be held on the Monday of the following week.
